# **GENERAL INFORMATION**

AWARDS:	Divisions will be pinned separately. Ribbons first place through sixth place for each class.
CHAMPIONSHIPS:	High Point, High Point Reserve, and High Percentage for each level in each division.
STABLING:	Limited 12x12 permanent stall. \$75for weekend (stalls available 3 pm Friday through 3 pm Sunday) or \$40.00 per day/one overnight. (Stalls available 3pm Friday to 5pm Saturday or 6pm Saturday to 3pm Sunday. Stalls available on a first come first serve basis, no reservations without payment. No tack stalls available. Light bedding provided, additional bedding available at \$7 per bag.  Stabling is reserved with entries at <a href="https://www.horseshowoffice.com">www.horseshowoffice.com</a> .  No phone reservations accepted. Upon check-in, a \$10 deposit will be collected for each stall. The \$10 deposit will be returned at the end of the day if the stall is left clean.
HAUL-IN FEE:	\$20 per non-stabled horse. No non-competing horses.
CAMPING:	\$15 per night. No hookups; may bring generators.
FOOTING:	Groomed sand competition arena and grass warm-up.
