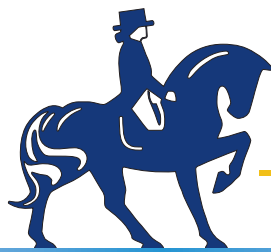

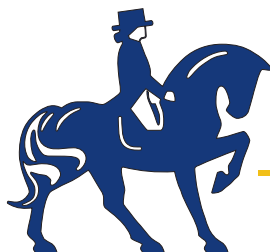

NATIONAL PONY CUP PARTNER SHOWS CHAMPIONSHIP SERIES

CDP is a Partner Show for the National Pony Cup and is offering a Mini-Series Championship at its three Shows: Mid Winter Dressage, Capistrano Dressage International, and Festival of the Horse. To be eligible, the same test must be ridden by the same rider/pony combination at a minimum of two of the three partner shows of this series. Six awards will be presented: Champion and Reserve Champion to the Junior/Young Rider, Adult Amateur, and Open rider for Pony Test of Choice. The NDPC Degree of Difficulty scale will be used to determine the highest average of the highest two scores for each rider/pony combination.

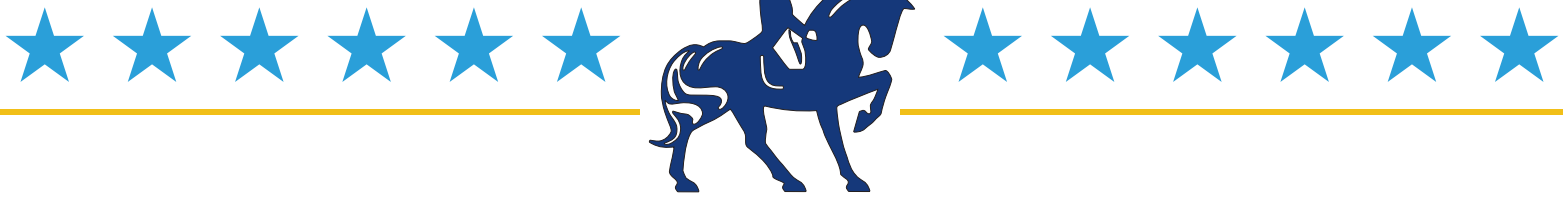

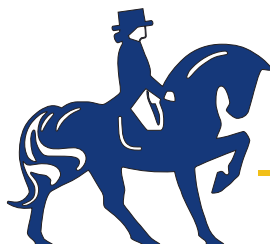

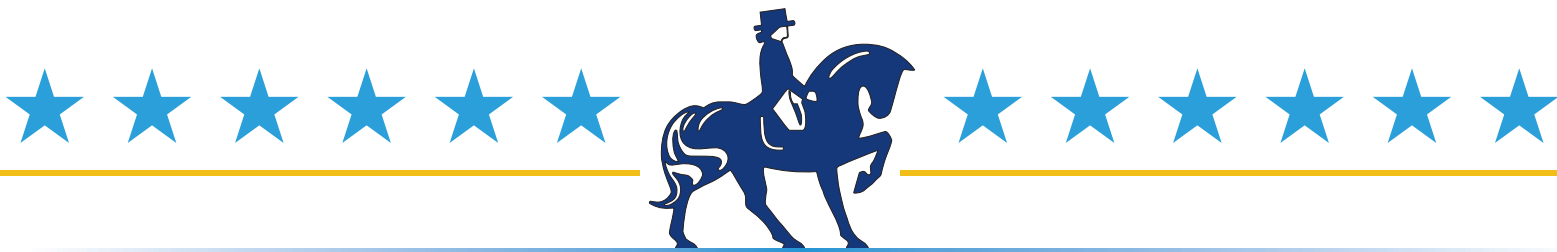

CDI INFORMATION AT A GLANCE

1. Early Arrival Tuesday March 8 at 2:00pm – Limited space for open horse in the CDI Barn.
2. Wed. March 9 in Barns Vet Inspection at 11:00 Official Jog is at 3:00pm.
3. Grand Prix riders limited two horses. Any changes to your choice for the Special or the Freestyle must be made before the draw on Thursday. Only 12 horses will move on the freestyle from the Grand Prix based on a score of 62% or better. All other horses will move to the Grand Prix Special.
4. Riders in the Small Tour are limited to two horses. Intermediate Freestyle is limited to the top 12 riders in the Intermediate I Class with a score of 62% or better.
5. Pony Riders Limited to 2 ponies per rider, IF there is sufficient time between their riders.
6. Junior/Young Riders: Qualifying for the Freestyle from the Individual Test with a 60% or higher.
7. CDI Amateur Riders may not be listed on the FEI World Ranking List. You do not need an FEI passport if you are a US citizen, you do need a FEI passport if you are a foreign athlete competition in the US and you will need official permission from your NF.
8. **Remember you need to come to the show office and pick up your passport before leaving the showground.**



CHAMPIONSHIP SHOW QUALIFICATIONS

CDS Annual Championship Show and USDF Region 7 Championships will be held at the Murrieta Equestrian Center - September 21–24, 2017.

To Participate in CDS Championships:

Owner & Rider:

Must have a CDS Membership at the time qualifying scores are earned and at the time of the championships.

Minimum Qualifying Scores:

A horse/rider combination must achieve the following scores for CDS qualifying: When two (2) or more judges score a single ride, the combination of judges counts as ONE judge and the average of their scores counts as ONE score. Horses must be at least 4 years old. Scores can be earned at any test of the level. Training through 4th level requires 5 scores from 4 different judges; FEI levels require 3 scores from 2 different judges and freestyles require 2 scores from 2 different judges.

To Participate in USDF Championships:

Owner & Rider:

Must have a USDF Participating* Membership (PM) at the time qualifying scores are earned and at the time of the championships.
Must have a USEF membership (Jr. Active, Sr. Active, or Life) at the time the qualifying scores are earned and at the time of the championships.

Horse:

Must have a USDF Lifetime Horse Registration (LTR) at the time qualifying scores are earned and at the time of the championships.
Must have a USEF (Annual or Lifetime) Membership recorded at the time qualifying scores are earned and at the time of the championships.
USDF horse registration and USEF horse/recording must be in the name(s) of the current owner(s) or lessee(s) of record.

** PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.*

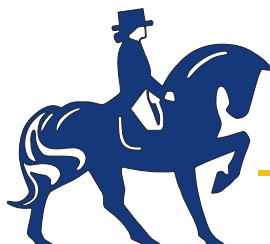
Minimum Qualifying Scores:

Two scores from 2 separate judges and 2 separate shows must be earned at the highest test in each level with an extra \$10 fee and "Q" added to the test before the start of the class. One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for levels through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

USEF RULES YOU MAY NOT KNOW AND HOW THEY AFFECT YOU:

RULE: DR 126.1B-4

Dressage classes must be run in their entirety and rides may only be scheduled out of sequence to allow a reasonable interval between two or more horses entered by the same rider in the same class or in different classes.

AFFECT:

We can not always move a ride time for you or let you ride out of order for a class that goes earlier/later because it would be a violation of this rule. Whenever we can, we will try to accommodate your specific requests for ride times while still observing the USEF rules.

RULE: DR 126.1B-5

At least 50 minutes must be scheduled between start times for a rider's tests on different horses unless he/she has agreed, in writing, to a shorter interval between tests.

AFFECT:

We always tries to give a minimum of an hour between horse changes; however, at times you may have to ride within a shorter time. We apologize and hope you understand that we are doing our best for all the exhibitors. This rule does NOT apply to rides on the same horse and those may be scheduled closer together.

RULE: DR 119.5

Only with the permission of competition management may a horse/rider combination enter a class Hors de Concours. Such entries must pay the full entry fee but scores for these entries will not be published or recorded, nor shall they count towards any prizes, placings or year-end awards. Said permission must be granted prior to the start of the class(es) involved. Hors de Concours entries must follow all Federation General and Dressage Division rules that apply to other entries in the same class, except as described below. Having competed Hors de Concours at a competition, a horse is no longer eligible for further prizes, awards or placings at that competition except in situations of emergency substitutions of judges. Hors de Concours entries are not permitted in Federation/USDF Championship classes.

AFFECT:

You would like to show - but don't want your scores to show up on scoreboard or in official results, but want feedback from judges. This is great to have a way to school at an official show.

SPECIAL INFORMATION FOR CDI COMPETITORS

This event is organized in accordance with: FEI Statutes, 23rd edition, effective 29th April 2014, FEI General Regulations, 23rd edition, effective 1st January 2009, updates effective 1st January 2015 - FEI Veterinary Regulations, 14th edition, effective 1st January 2015, Equine Anti-Doping and Medication Control Rules (EADMCR), effective 1 January, 2015. Rules for Dressage Events (25th edition, effective 1st January 2015), and all subsequent published revisions, the provisions of which will take precedence. All FEI rules and regulations will be strictly enforced.

An arbitration procedure is provided for in the FEI Statutes and General Regulations referred to above. In accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies is to be settled exclusively by the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland.

Foreign Federations: The following foreign federations have been invited to attend: AUS, BER, CAN, COL, DEN, EGY, ESP, FRA, GER, GBR, IRL, ISR, JAM, MEX, NED, NZL, PUR, RSA, SWE, SUI, TWN. A maximum of twenty riders per foreign federation and no more than four horses per rider may participate. There are no restrictions on the number of foreign riders declaring for World Cup participation. Competitors are invited by the Organizing Committee (OC) through their NF. One groom per rider. If a class has filled when an entry is received, the competitor will be wait listed and put into a class as openings become available.

1. Rider Eligibility: Competitors must have reached or will reach their 16th birthday in 2016 and must be licensed by their National Federation and may only take part under the jurisdiction of the NF of the country from which they hold their passport. If not a U.S. citizen, they must be nominated by an invited foreign NF. Riders must be prepared to produce their license or USEF membership card on request of the Organizing Committee, and the name on the entry must be the same as appears on the license.

2. Horse Eligibility: Horses must be a minimum of six years of age (7 years for Grand Prix). Mares may not compete after their fourth month of pregnancy or within nine months after foaling date. The nationality of a horse is that of its owner or of the country in which the company owning it is registered. *Horses must have an official FEI Passport. The US Equestrian Federation will provide information on veterinary requirements for foreign horses entering the USA. Horses must be stabled on the grounds and may not leave during the event (commencing with the Veterinary Inspection and ending with the pinning of their final FEI class). Each horse will keep the same number throughout the event. It is compulsory for this number to be worn by the horse, when outside his stall, so that it may be identified by the stewards.

3. Awards: Awards will be distributed to 25% of participants in each competition. Prize money will be mailed within 10 days of last day of event. Riders are to appear formally attired and mounted for all award ceremonies.

4. Arenas: Competitions will take place indoors in 20M X 60M sand-mix footing. Warm-up will be across from main arena in 20M X 60M sand-mix arena.

5. Expenses: The Organizing Committee is not responsible for any expenses of competitors, horses, owners, their employees or agents, and does not offer expense allowances or reimbursements.

6. Stable Fee & Access: Only identified riders, trainers, grooms, farriers, treating veterinarians, officials, organizing committee members and two owners per horse will be authorized to enter the stable area. For Stable fees, please see general rules.

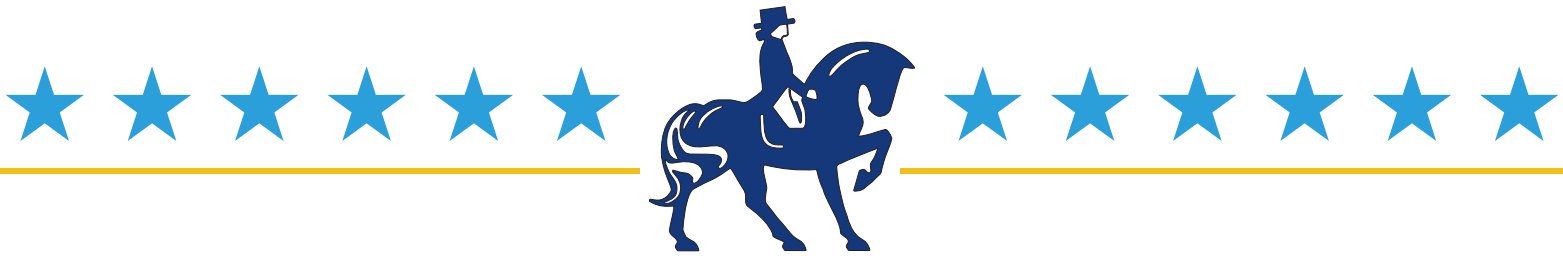
7. Logos: Competitors may carry only the logo of their personal sponsor on each side of their saddle cloth. It must not exceed 200 sq. cm.

8. Tack check: A steward will check the saddlery of each horse immediately after the horse leaves the competition arena. Any discrepancy will entail immediate elimination. All areas and arenas will be supervised.

9. Objections: All complaints, in order to be valid, must be made in writing and accompanied by a deposit of the equivalent of 150 Swiss Francs.

10. Organizers Rights: The Organizing Committee retains the right to split, cancel, or change the day of a class or to further restrict the number of horses a rider may ride in any one class, also to cancel the event under special circumstances with the permission of the AHSA and the FEI, and return entry fees.

11. Insurance: All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.



SPECIAL INFORMATION FOR CDI COMPETITORS CONT.

12. Starting Order: A draw will be held each day to determine the starting order for the next day's classes. Exact time and location of the draws will be published in the secretary's office. The starting order for the Grand Prix Musical Freestyle will be as follows: Draw in groups of 5 in Reverse order of placing in the Grand Prix. The Grand Prix Special will be as follows: the riders placed 7th to 12th in the Grand Prix will start first, followed by those placed 1st to 6th. The starting order within each group will be determined by draw. A draw time cannot be changed. Riders must declare by the drawing on the day before the class. Once declared, a rider may not withdraw, except as specified in the FEI rules. FEI rules provide for penalties for scratches without good cause.

13. Intermediaire I Freestyle: Participation is open to a maximum of the 12 best riders who qualified in the Prix St Georges and/or Intermediaire I competition. The starting order will be determined by a draw.

14. Grand Prix Special: Participation in the Grand Prix Special is limited to, and compulsory for, up to the 15 best rider/horse combinations who enter the Grand Prix - Qualifier for the GPS. Riders are obliged to start in the Grand Prix Special if qualified by their placing in the Grand Prix.

15. In Barn Inspections: In Barn inspections will start at 10:00 am the day before the first competition for all competitors entered in CDI competitions. Horses will be examined to verify their identity, age, state of health, correctness of passport and fitness to compete. The Person Responsible for each horse must be present unless a written request has been approved by the FEI Veterinarian. If the rider is under 18, the committee must be given the name of the adult who shall be the Person Responsible. The Jog will then be conducted at 3:00 pm at a location to be determined.

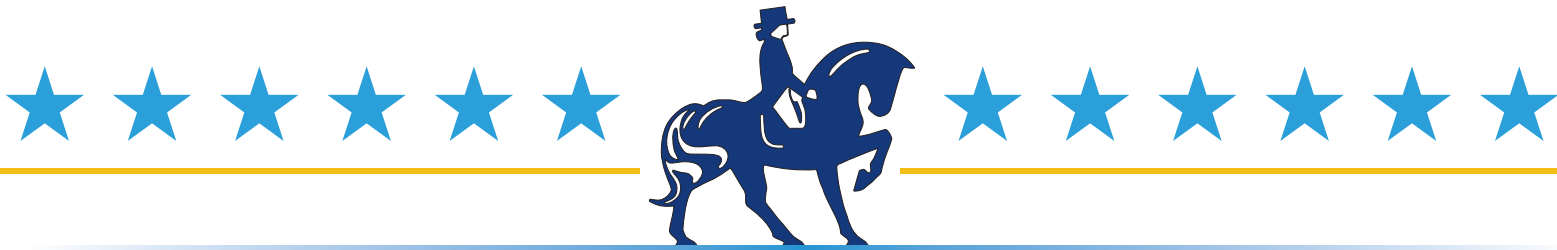
16. Veterinary Examinations: Inspections and Passport Control: These will be carried out in accordance with Vet. Regs. Art. 1011; Rules for Dressage Events Annex I. General Regulations 23rd edition, 2009 will apply: In accordance with Art. 139.1 Every horse entered for any competition at CDNs, CDIs* and CDIs** in a foreign country, and all horses entered for CDIs***, CIOs, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official FEI Passport, or a National Passport approved by the FEI as a means of identification and to establish ownership. In accordance with Art. 139.2 horses taking part in CDNs, CDIs* and CDIs** in their own country are not required to have such a passport as is mentioned in paragraph 1. All such horses must be properly registered and unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin, all horses must have a valid vaccination certificate.

17. Equine Influenza Vaccination: Vet. Regs. Annex VI - All horses and ponies for which an FEI Passport, or a National Passport approved by the FEI, has been issued must have the vaccination section endorsed by a veterinarian, who is not the owner of the animal, stating that it has received two injections for primary vaccination against equine influenza, given no less than 21 days and no more than 92 days apart. In addition, a booster injection must be recorded as having been given within each succeeding 12 months, subsequent to the second injection of the primary vaccination. None of these injections must have been given within the preceding 7 days including the day of the competition or of entry into the competition stables. The above are the minimum requirements for influenza vaccination. Both primary and first and subsequent booster injections should be given according to the manufacturer's instructions which will fall within the stipulation of the FEI ruling. In many cases booster injections are recommended by the manufacturers at intervals more frequent than 12 months. The FEI Veterinary Committee strongly recommends booster vaccinations every 6 months.

18. Sampling for Prohibited Substances: Vet. Regs. Chap. V & VI and Annex III - Special guidelines are applicable for events covered by the FEI's Medication Control Program (Groups I and II only). At all other international events horses are subject to sampling of Prohibited Substances. Such sampling is compulsory in CDI Os, World Cup Qualifiers, Cup Finals, Championships and Games, and is recommended for other categories of CDIs. (Art. 1017.1).

19. Medication Control Program (Groups I & II Only): Competitors at CDIs***, CDI Os, Championships and Games must pay the equivalent of Sfr 12.50 per horse per event to the Organizing Committee towards the costs of the above Program.

20. Approved Laboratory - US Equestrian Federation Drug Testing and Research Laboratory, Ithaca, NY.



RULES AND GENERAL INFORMATION

1. All Cornerstone Event Management shows, are covered by the rules and specifications of the current US Equestrian Rule Book and will be conducted and judged in accordance therewith.

2. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

3. Federation Entry Agreement

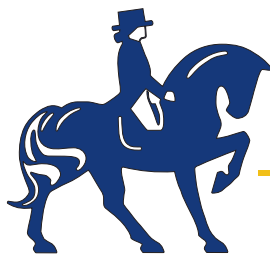
By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of The Blenheim Holiday and Winter Classics I and II (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

4. ASSUMPTION OF RISK: By signing the entry blank, the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur acknowledges that horseback riding, particularly jumping, is a dangerous activity and involves inherent risks that may cause serious injury and in some cases death because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance and expressly assumes all such inherent risks whether identified herein, in the entry blank or in the Federation Rules and Regulations. A horse, without warning or any apparent cause, can buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's foot, or push a person--all of which may cause the rider or observer to fall or be jolted, resulting in serious injury or death. A horse may also become loose and cause injury to an observer or rider or to another horse--a loose horse can run at full gallop in a panic and run into objects or persons or other horses. The Show Ground Facilities are bordered by highways/roads and thus noise from traffic and other sources occurs that can and will cause a horse to unexpectedly spook or react quickly. The Show Ground Facilities contain roads and driveways that are traversed by cars, golf carts, tractors, trailers and heavy equipment all of which may spook a horse. The above warnings and risks are meant as an example of some of the risks that are inherent and may be encountered but it is agreed this is not an exhaustive list and there are numerous additional conditions and/or events that may result in injuries while participating in the Competition and/or being present on the Show Ground Facilities.

5. Amateurs, Juniors & Young Riders: Amateurs are defined by the rules and specifications of the current USEF Rule Book.

All riders entering the Amateur classes must possess or have applied for an USEF Amateur Card prior to riding in the class. **All riders in Amateur Divisions must present a USEF Amateur Card when picking up their number or they will not be allowed to show in the Amateur Division.** Cards may be applied for at the show office. Jr/ YR rider classes are offered to anyone 21 and under (may compete until the end of the calendar year in which they turn 21). Young Riders are eligible for FEI Young Rider classes from 16-21 yrs. of age.

6. CONDITIONS OF ENTRY: Every horse entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show and its Directors harmless for any loss or accident to his horse, horses or equipment which may occur from sickness, fire or otherwise.



RULES CONT...

7. ENTRY PROCEDURES: PLEASE READ CAREFULLY!!

- A. Office and Stabling fees:** For each horse entered, send your completed entry form along with all entry fees, stabling fees or grounds fee, and a \$20 office fee for each show day entered. ALL FEES must be paid with entry.
- B. At the Show:** Bring cash, check, or credit card for all the remaining fees to the show. No numbers will be issued without full payment and completed entries, including signatures.
- C. Entry Acceptance:** Entries will be accepted on a first come-first serve basis until classes are filled. Entries received after classes are filled will be notified and, if desired, put on a waiting list. Those on a waiting list not getting into the show will have all fees refunded. NO PHONE entries will be accepted. All entries must be made on official entry blanks and filled out completely as to classes, exhibitors names, addresses, phone numbers, association numbers, and signatures. Parents or guardians must sign the official entry blank of a minor before a number will be released. **Entries close and MUST BE RECEIVED BY CLOSING DATE OF EACH SHOW.**

8. TESTS: The Current USEF & FEI tests will be used.

9. SCRATCHES: Exhibitors have the responsibility of informing the Show Office of their intention to scratch. Scratches before the closing date may be made for any reason and all fees will be refunded except office fees. If you decide to scratch any of the classes after the closing date, you must inform show management in writing to 818.840.8208 or Glenda@glenroys.com accordingly. NO REFUNDS, INCLUDING STALL FEES, AFTER CLOSING DATE FOR ANY REASON. No-Shows will be billed for all unpaid entry fees.

10. LATE ENTRIES: All entries must be RECEIVED on or before the closing date or will be considered a late entry. Each late entry will be charged a late fee of \$100.00. Late entries will be accepted and given a ride time only as schedule permits.

11. UNPAID CHARGES: Any exhibitor leaving the show with an unpaid balance of entry fees or feed bill, will be billed for these charges and a \$100.00 billing fee will be added to the total due. Until these charges are settled, all future entries of rider and owner will be returned.

12. RETURNED CHECKS: Checks returned by the bank will be handled according to the following procedure: A 10% penalty (minimum \$50.00) will be assessed for each returned check.

13. RIDING TIMES: Preliminary ride times will be emailed and final ride times will be put on the website at www.cornerstonedressage.com by 5:00 pm the day before the show for all exhibitors - Ride times will also be available at the showgrounds at 5:00 pm the day before the ride is scheduled. Adequate time intervals cannot be guaranteed when riders enter more than one horse in any class. If you enter classes in different levels or divisions ie. Open - Amateur or junior , there may be a considerable time between rides. It is the responsibility of the rider to inform the management of any time conflicts at least 24 hours before the scheduled rides. Any changes after the show starts will be charged a \$15.00 office fee.

14. ARENAS: 20 x 60 arenas of composition footing. Only horses entered in the show will be allowed in warm-up area. No one on foot is allowed in designated warm-ups. Lungeing is to be done ONLY in specified areas. All horses in the warm-up arenas must wear their competition numbers. All arena must be vacated while equipment is being used.

15. RIBBONS AND AWARDS: In classes where three or more riders complete the class, the winner will receive an award. If less than three, ribbons only will be given. Ribbons are awarded to fifth place

16. MANAGEMENT: Horse Show Management reserves the right to itself to interpret all questions and conditions in regard to or arising out of any incident in the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by the Horse Show Management; their decision will be final. The Horse Show Management reserves itself the right to refuse, accept conditionally, or to cancel any entries, disqualify riders or exhibitors, prohibit exhibition of entries and cancel award prizes, without claim to damages; to change, cancel or combine any classes, to reschedule classes after due notice to exhibitors, or to change rings or rotate judges.

17. FEED AND BEDDING:

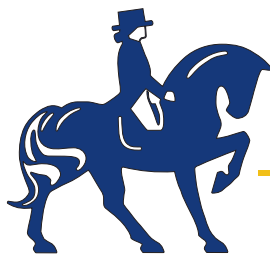
LAEC: Advance orders may be made by faxing feed and bedding order form to US Horse and Feed. Feed and shavings orders must be made by 1:00 PM in the feed office at LAEC for same day delivery. Please call **US HORSE AND FEED AT (818) 559-9699 with questions. Exhibitors must pay feed bill before leaving show grounds.**

SAN JUAN CAPISTRANO: Hay and Shavings will be available and can be ordered in the Horse Show Office. Advance orders may be made by faxing feed and bedding orders to 818.840.8208. Orders must be placed by 12:00 pm for same day delivery. Exhibitors may bring their own feed/shavings; however, deliveries by outside feed/shavings companies are prohibited. Exhibitors who bring their own shavings may be subject to a clean up fee.

18. HOSE/ WASHING: Do not wash horses in barn area. Please use the wash racks. We recommend that you have a garden hose available.

19. STALL CLEANING: Manure must be placed in designated areas. Trash must be kept separate from manure. **A violation will result in a \$100 fine.**

20. STABLING:

NO STRAW IS PERMITTED – ONLY SHAVINGS FOR BEDDING. NO FIRST BEDDING is provided, but may be ordered prior to the show. Permanent stalls are of wood construction, 12' X 12" with dutch doors. If you need to arrive before Wednesday or stay longer than Sunday, you must call and make special arrangements (818) 841-3554, we will try to accommodate you depending on the schedule at the Equestrian Center

COSTS: CDI Stalls \$200.00

All other stalls are \$175.00

Additional days will be charged \$50 per day; \$75.00 for day stall.

Any exhibitor using straw will be assessed an additional charge. Any exhibitor removing stall doors will be charged an additional \$100.

21. SCHOOLING HORSES: SCHOOLING HORSES WILL ONLY BE ACCOMMODATED IF THERE ARE SUFFICIENT STALLS AND SCHOOLING ROOM AFTER ALL SHOWING HORSES HAVE BEEN ENTERED. Horses not entered in the show must be registered with the Horse show office and will be given a number to be worn at all times outside of the stall. Appropriate stall or ground fees, drug fees and a \$50 Per show day schooling fee must be paid. Any person(s) riding a schooling horse must have signed an official entry blank and/or release form. No school horses are allowed in the warm-up area during the competition.

22. PROTESTS: Any exhibitor lodging a protest must first deposit \$100 with the secretary of the show, which sum will be forfeited to the Horse Show if not sustained. All protests must be filed in writing, signed by the protester, and filed with the Show secretary within 48 hours of the occurrence of the alleged violation.

23. DOGS ARE A SERIOUS SAFETY AND HEALTH PROBLEM AT ALL HORSE SHOWS. Dogs must be confined to the stable area at all times and be leashed!! Any dog's owner will be fined \$100 and may be asked to leave the show grounds if his/her dog is caught or even OBSERVED outside the stable area. Los Angeles Equestrian Center/Blenheim EquiSports is serious about dog control. Owners are expected to clean up after their dogs.

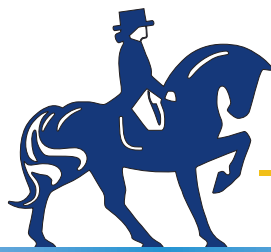
24. PARKING: All vehicles must be parked in designated parking areas. Access roads adjacent to the barns are for loading and unloading only! Unauthorized vehicles in non-designated parking areas or permit only parking areas are subject to tow away at owner's expense. CVC22658 CVC22500.1.

25. OVERNIGHT PARKING: A limited number of spaces are available at a rate of \$75.00 per night. Display proper passes. Passes may be picked up from the horse show office. Overnight parking is allowed only in the RV Lot.

26. RAIN SCHEDULE: In the event of rain, times will be rescheduled to accommodate as many rides as possible - if we cancel your class, your money for that class will be refunded - if you scratch a class that is rescheduled, you will be liable for all class fees.

27. VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/ or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

28. HELMETS: Effective April 1 2013, for dressage: Anyone mounted on a horse must wear protective headgear.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$75), 5-years (\$300), or life (\$1,500). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$60). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards, Great American Insurance Group/USDF Breeders Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$200) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (EM): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$25 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$25). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$70. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$95) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
