### CLASS & SHOW FEES:

- Combined Tests - \$55 (Classes 1 – 11)
- Jumpers - \$25 (Classes 12 – 27)
- Dressage - \$35 (Classes 28 – 54, 60-61)
- Leadline - \$15 (Class 55)
- Dressage Seat Equitation - \$25 (Classes 56 – 59)
- Office Fee - \$10 (If entered online through Horse Show Office or mailed via USPS)
- Office Fee - \$15 (If entered by emailing entry)
- Haul-in Fee per horse - \$10 (Not Required for OEC Boarders – indicate on Entry)
- Late Fee - \$25 (Entry and/or payment received after March 15, 2021 (11:59pm))
- Guest Horse - \$20 plus Office and Haul in Fees – Late fee added if entry received after closing date.

**ENTERING THE SHOW: Each rider / horse combination must be entered separately.**

### NOTES:

- If you are a **Boarder** at Oldfield Equestrian, the **Waiver/Release of Liability (Entry Agreement), Vaccination Record and Coggins Report** are **NOT** required.
- If you have submitted a **Waiver/Release of Liability (Entry Agreement)** for 2021, this document is on file and is not required for entry.
- Also if the **Vaccination Record and Coggins Report** are within the time requirements and have been submitted prior, these documents are **NOT** required.

### ONLINE at Horse Show Office

  - Identify the Show on the Events list of shows.
  - Print out the Entry Agreement. (This document is the Oldfield Facility Waiver and Release of Liability)
  - Complete and sign the Entry Agreement (Facility Waiver/Release of Liability).
  - Scan or take a picture of the completed and signed Entry Agreement (Facility Waiver/Release of Liability).
  - Scan or have pictures of the horse's Vaccination record and Coggins Report. See more information on the next page.
  - Select the show and complete the entry.
  - After entering and paying, upload the Entry Agreement (Facility Waiver/Release of Liability), Vaccination Record and Coggins Report to complete the entry.
- A confirmation email will be sent from Horse Show Office to the email address provided and includes a link if documents or payment are required.

  - Mail the Entry form, Entry Agreement (Facility Waiver/Release of Liability), Vaccination Record, Coggins Report and check to:

#### Awards:

- All classes will be separated into Seniors and Junior/Young Riders.
- First through Sixth place ribbons will be awarded.
- A Combined Training Low Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the lowest score (Classes 1 through 11). A Dressage High Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the highest score (Classes 28 – 54). **Attire:** An ASTM Approved helmet must be worn AT ALL TIMES when mounted and footwear should have a distinguishable heel while riding. Breeches or jodphurs with a collared shirt are required. Tall dressage, field or paddock boots are required. Half chaps are also allowed if wearing paddock boots.

**Arenas:** One (20m x 40m) dressage arenas will be used for Classes 1-10, 28-36, 55, 60-61. One (20m x 60m) dressage arena will be used for Classes 11, 37-54, 56-5. A separate jumping turf field with some grading will be used for combined test stadium and jumper rounds.

**Guest Horses:** Horses **NOT** entered in classes but attending the show must have a completed entry form (for each horse), Entry Agreement (Facility Waiver/Release of Liability), Vaccination Record and Coggins Report by the closing date (6/2/21). The fees for each guest horse are \$20.00, haul in fee \$10 and a \$10.00 office fee (add \$5 to the office fee if entry is emailed.) Each guest horse is required to wear a number when off the trailer. The number is obtained at the Check-in Office. Late fees apply if requested after 6/2/21.

**Ride Times:** Times will be emailed to the email address on the entry form by Friday, 6/4/21. Please contact the show secretary, Carol Freligh, at [frelighc2805@gmail.com](mailto:frelighc2805@gmail.com) or 843-857-6229 if you have questions or special requirements.

**STABLING: NO STABLING available.**

**Haul in Fee:** A haul in fee is assessed for each horse entered in the show. Oldfield Boarders are NOT charged a haul in fee and should indicate in notes, "boarder" when entering online at Horse Show Office.

**Entry Agreement (Assumption of Risk, Release of Liability and Indemnity Agreement):** Each rider must complete the Agreement and include it with the entry form. If the rider is 17 years of age or younger, a parent or guardian **must** complete the Agreement. The Agreement is kept on file for 2021 and is not required to be repeated for a rider for the year 2021. If rider is an Oldfield Boarder, state "boarder" on the entry or in the Horse Show Office notes section.

**Vaccination Record:** Each horse entered in the show must have proof of EHV4-1 (Flu/Rhino) vaccination within 6 months of the show date. Not required for Oldfield Boarders. If rider is an Oldfield Boarder, state "boarder" on the entry or in the Horse Show Office notes section.

**Equine Infectious Anemia (Coggins) Report:** Each horse entered in the show must have proof of a negative coggins within one year of the show date. Not required for Oldfield Boarders. If rider is an Oldfield Boarder, state "boarder" on the entry or in the Horse Show Office notes section.

### **Oldfield October 9, 2021 CT, Jumper and Dressage Championship Schooling Show:**

All competitors are welcome to show their horses in the regular classes normally offered at Oldfield Equestrian Center during the Championship Schooling Show. Horse/Rider Pairs that are **eligible for championship classes** will be notified by email by the opening date of the show. Championship classes will be listed separately on the October 9<sup>th</sup> Schooling Show prizelist.

#### **Eligibility requirements:**

- Participation in two of the four shows qualifies a rider/horse pair to compete in the Oldfield 2021 Championship Schooling Show classes.
- Rider and horse must show as a pair throughout the Oldfield 2021 show series. Show dates are 4/25/2021, 5/15/2021, 6/5/2021 & 9/25/2021.
- A rider/horse pair can compete and become eligible in both Combined Training and Jumpers.
- A rider/horse pair may only compete in the Championship class(es) for which they are eligible based upon the level(s) shown at the Oldfield Show Series listed above.
- Championship classes will be separated into Jr/YR and Sr divisions. Championship classes include: Intro through Intermediate Combined Tests, Cross rail Jumpers through 3'6" Jumpers.

#### **Awards:**

- Champion, Reserve Champion and 3<sup>rd</sup> through 6<sup>th</sup> place ribbons will be awarded. Trophies/awards are TBD.
